Mr. Dodd taught Texas Real Estate Law in the Legal Assistants Program at the University of Texas.

Mr. Dodd is a Fellow of the Texas Bar Foundation, a Founding Fellow of the Austin Bar Foundation, and a member of The College of the State Bar of Texas.
