Course description:

This course examines women and gender in China from imperial times to the present. Major themes include the changing conceptions of femininity in Chinese cultural and religious contexts; gender roles and inequalities in the patriarchal family and society; the varying discourse on women and gender in the modern period; women's dilemma in the Chinese Revolution; new challenges to women and new conceptions of gender and sexuality during the reform era since the 1980s. There is no prerequisite for attending this course, but some background in Chinese history is recommended.

This course carries the Global Cultures flag. Global Cultures courses are designed to increase your familiarity with cultural groups outside the United States. You should therefore expect a substantial portion of your grade to come from assignments covering the practices, beliefs, and histories of at least one non-U.S. cultural group, past or present.

Assignments and grading:

- Weekly report (10%): This is an undergraduate seminar with a substantial writing component. You are expected to read at least two chapters/articles each week from the weekly reading assignments before class and write a one-page report on one of the readings. Your report should summarize the main points of the reading, make your own comments, and raise a question for class discussion. You are expected to write 10 reports during the semester and email each of them to the instructor by 12 pm on Monday.
- 2) Class participation (10%): You are expected to actively participate in discussions and do presentations.

- 3) Mid-term exam (40%): The mid-term on October 17 consists of IDs and short-answer questions.
- 4) Research paper (40%): You are expected to write a paper of 10-12 double-spaced pages, on a topic of your choice and with the instructor's consent. Proposal is due April 12. The paper is due and to be presented in class on May 3.
- 5) Attendance: Students are expected to attend all class meetings and are responsible for signing in on an attendance sheet during each class. You are allowed one unexcused absence; additional absences will adversely affect your final grade, 5% for each missed class and up to 20%.
