### **Public History Project, Current**

#### <u>Austin Women Activists Oral History Project</u>

Founded in 2017, this ongoing project has produced a digital archive at the Briscoe Center for American History, the <u>Austin Women Activists Oral History Project Records</u>. Open to researchers since March 2020, the collection focuses on the 1960s and 1970s, and currently comprises professional quality audio and transcription files representing 28 oral histories, nearly all conducted by students in my undergraduate seminar at the University of Texas at Austin. The project has won recognition through the production of a documentary film, *Fight Like a Girl: Women's Activism Shapes History*, an awardwinning article of the same name in *Life & Letters*, and a feature story on *Not Even Past*.

The Austin Women Activists oral History Project has earned financial support from several entities and individuals, most notably the College of Liberal Arts and History Department; institutional assistance from the Briscoe Center, the Benson Latin America Collection, the Division of Diversity and Community Engagement, the Faculty Innovation Center; staff support from the UT History Department and the Captioning and Transcription Center; and invaluable guidance from UT alumna Alice Embree, Linda Jan Lewis, and Glenn Smith (d. 2019), without which the project would not have been possible.
