COURSE OBJECTIVES

In today's global economy, professionals must understand the relationships, institutions, and environment that underlie international commerce. The primary objective of IB 320F is to extend your knowledge of the global economy so that you can be a more effective manager in business – whether or not you actually work in a global corporation. I hope it will also help you to be an educated citizen, understanding the major issues impacting government policy and globalization. The topics in the class have been selected to address both theoretical and practical dimensions of the global economy.

The course has the following objectives:

1. To give you tools to analyze and understand the global economy overall, along with the business environments of individual countries. These tools include:
 - theories related to international trade and investment
 - major indicators of global business activity, including the Balance of Payments
 - techniques to find relevant information regarding a country, how to analyze that information, and how to apply it in a professional context.
2. To give you knowledge of important things happening **right now** in the global economy. These include:
 - the continuing impact of globalization, both positive and negative
 - differing cultural, legal, economic, and political systems
 - the expanded role of emerging markets in the global economy, particularly in China, India, and Brazil, along with the impact of recent slowing growth in these regions
 - major organizations which influence international trade including the changing impacts of the WTO and the IMF in the global economy
 - economic and political changes in Latin America
 - the history and role of the dollar and the Euro and their long-term prospects
 - the impact of the Trump election on international economic relationships
3. To emphasize the role of government, politics, and public policy in international business, and help you assess government policy, both in general and for specific pieces of regulation or policies in other countries, as well as in the U.S..
4. To develop your knowledge of the evolution of the global monetary system and the resulting mechanisms and factors that influence currency exchange rates (and thus, corporate profits, market potential, and operational costs).
5. To increase your familiarity with the locations and names of the nations of the world and increase your knowledge of the economic conditions of key nations and regions in the global economy.
6. **MOST IMPORTANT:** By the end of the semester, I hope that you will think that the global economy is interesting, professionally relevant, and important enough for you to build on the knowledge you've gained in the course in order to keep abreast of the many changes that will occur in global business during your life. My overriding goal is that you be able to use the knowledge and skills you gain for your personal and professional development.

NATURE OF THE COURSE

IB 320 is a “macro” course. By that I mean that the course looks at international business primarily from the perspective of aggregate impact, general forces, and overriding theories, and not so much that of individual management decisions. That is not to say that the topics covered aren't relevant to business management – they most certainly are, but rather that the concepts covered in the class typically are not focused specifically

on individual businesses and business decisions. Still, as much as possible, I'll attempt to demonstrate ways that these larger forces impact business decisions and the Country Analysis assignment will allow you to make specific business and/or policy applications.

Because the course may cover many concepts that may be new to you, a significant portion of the material will be introduced through lectures and the textbook. Most of the lectures will be in class. I may assign a number of readings on different course topics in order to update material in the text, apply concepts we are covering, and to dive a bit deeper into some selected subjects. At the same time, I want to create as many opportunities as I can for you to direct your own learning and to learn from each other.

HOW TO SUCCEED



Come to class! Regardless of this being an on-line class **attendance is mandatory** as I will be giving you key material not found in the textbook. I also like to throw in questions on the exam that you would only know the answer to if you attend weekly.

- Complete the LearnSmart module and any articles assigned for a class day – **before coming to class**. Note the LearnSmart module due date for each chapter. **LearnSmart (LS) due dates are typically before our class lecture on that chapter**. Professor reserves the right to change LS due dates as needed. Professor also reserves the right to change the test dates as needed.
- Apply course concepts to current events and supplement your knowledge with the business press. Good options include: *The Financial Times*, *Business Week*, *Fortune*, *Forbes*, *Fast Company*, the *Wall Street Journal*, and *The Economist*. If you have to choose, the most comprehensive are *The Financial Times* and *The Economist*.
- **This is an online class**. You should **ensure you have the proper technology to succeed**. This includes tasks such as participating in Zoom lectures, Instapoll questions, breakout rooms, and online exams. You can not test using Chromebooks, ipad's or smartphones.
- You will be graded on your participation in class discussions (including technology tools that will help keep us connected like Instapoll). It's important for everyone to have an attitude of **honesty, openness, and respect**.

Content Responsibilities:

1. **Read the chapters and any articles assigned for the class day – BEFORE the class period**. **Make sure you check the website regularly** for new and revised assignments for each class period, particular if you miss class. If you are not already familiar with issues/concepts related to international business/economics, this is likely to be the MOST IMPORTANT thing you can do to perform well in the course.
2. As we cover different aspects of international business you will probably notice examples of concepts we cover in the world around you. **Look for these examples and make note of them**. As mentioned, you should begin to keep up with current events in business and international trade by regularly reading the popular business press. The particular publication best for you will depend on your interests and professional objectives, however, the best publications for international business interests are *The Financial Times* and *The Economist*. Whichever is your choice, you should be reading regularly (not only for this class, but for your other courses and general knowledge of business). **Bring your personal examples from readings and daily experience to class** for discussion of personal insights and current events. I am always happy for you to raise issues based on what you hear/learn from articles and news stories.

3. Because discussions can make a class more relevant, you can make this a more interesting class by engaging in the discussions. If you are someone who doesn't regularly participate, open up a little and let us learn from you. For there to be productive discussions it is VERY important that everyone have an attitude of **honesty, openness, respect, and fairness**. At times we may venture into topics where you or others have strong opinions. While you should always keep an open mind and respect others' viewpoints, you should also feel free to express your own opinions – whether I or others agree with you or not.

Please **DO** make suggestions about how to make the class time more productive and the course more effective in helping you reach your learning goals.

Professional Conduct for On-line Class

- Please be on time and ready to start when class begins.
- Please be mindful of your space and surroundings. I will ask that **cameras remain turned "ON" during class**. Therefore, whatever you can see...we can see too! Please use good judgement as you would an in-person class.
- If you need to leave during class, make your exit as inconspicuous as possible.
- Please turn off your cell phones before class starts. If you need to make an urgent call or send a text message, please leave class briefly.
- If I (or the TA) ask you multiple times to turn "ON" your camera and you ignore us (or always have the same excuse), we will drop you from the Zoom call and you will not earn class credit or be able to make-up missed instapolls.
- If you turn your camera "OFF" to take a short bathroom break, etc you must turn your camera back "ON" immediately when you return to our virtual classroom.

GRADING

Your grade in the course will be determined on the basis of the highest score of three of four equally weighted examinations. Each exam will include **30 or 40 multiple-choice questions or True/False**. If appropriate, I may apply a class curve. *However, requests for adjustments to individual grades cannot be accommodated due to the large size of the class and multiple tests offered.* The questions will cover all the material covered in the textbook and class lectures. You are responsible for **EVERYTHING** covered.

The questions will emphasize on concepts and major points, not minutiae. However, some questions designed to reward class attendance and attentiveness may be incorporated.

Exam grades will be posted on Canvas. All exams will be available for review with the professor for TWO WEEKS following the posted grades via a private Zoom call with the professor. After the two-week period, the exams are no longer available for review. Because of the size of the class, we cannot extend this beyond the stated time frame.

Final grades will be assigned based on your semester average. **See grade scale posted in Canvas** for details.

To be fair to all students, grade changes or personal extra credit opportunities will not be considered. There will be no exceptions. No arguments about +s or –s because this would remove the benefits of the +/- multiple test system, which was introduced to ensure a more accurate grading system. **The way to get the grade that you want is by EARNING it *during* the semester.**

EXAM POLICIES

All tests are on-line. A reasonable amount of time will be given to answer each question. You will be able to see one question at a time. You must answer the question to advance to the next question. Students starting late to the tests will not be given extra time. Instructor reserves the right to have students test with the Proctorio camera feature. ***Please ensure you have the proper technology to take an on-line tests (note: chromebook, tablets, smart phones, etc will NOT work).***

Please consult the Canvas calendar and establish that the exam dates/times will not conflict with your schedule during the first day of class. ***You must take the exam on the dates/time indicated in the class schedule.***

No alternative test dates or times will be provided *except as required for those students presenting a letter of accommodation from the Dean of Students SSD office.* *All such letters should be delivered as soon as possible. Late letters may not be honored if instructor does not have sufficient time to adjust on-line testing times. Students who need extra time or quiet will still take the exam at the same time as the whole class. However, they will be in a setting to accommodate their need for quiet and/or longer time.*

NO MAKE-UP EXAMS are offered for students who miss an exam. Remember that if you miss an exam, you will be given a zero. However, we will only count your three highest exam scores.

The following rules are key to exam efficiency in a large class. Failure to any of these rules will result in a penalty:

1. You must start your on-line test on time. No extra time will be given to late test takers. Canvas time stamps your test times. I typically open the test 5 or 10 minutes early, so you can log in early and ensure your technology is working. Keep in mind, once you answer the first question the clock is running.
2. Turn off all cell phones, pagers, calculators, or any other personal technology device during exams, and do

not have them on your desk or otherwise visible during the exam. No additional notes, books, headphones, or tools are allowed. This is for exam security.

Completed exams will be available for review with the professor for two weeks only following the posted grades. You must schedule an appointment to meet privately with the professor to do this. No grade discussions of any kind (other than to correct data entry or calculation errors) will occur at the end of the semester.

Learn Smart: For every course chapter/topic (11 total) you will be assigned an online learning exercise called Learn Smart. Learn Smart will take about 30-45 minutes to complete. The program will give you a series of question about the chapter and will “re-issue” questions on any concepts you miss. You should read the textbook chapter first and then initiate the Learn Smart program for that chapter. The purpose is to give you an incentive to make sure you read the assigned textbook material before class. You must complete the Learn Smart exercise to earn credit. In addition to the 11 Learn Smart exercises, there will be a handful of Instapoll quizzes covering special topics (normally discussed during class lectures...so come to class!). There are NO-MAKE UP’s for missed Instapoll’s given during live classes.

Class Participation: Throughout the semester, we will have impromptu in-class discussions related to the class material, current events, and country topics. You are encouraged to bring up relevant topics for discussion during class. The instructor reserves the right to use other interactive software to keep the class engaged. If I (or the TA) ask you multiple times to turn your camera “ON” and you ignore us, you will be dropped from the class call and not given credit or allowed back into the Zoom. Do not simply turn your camera “ON” and walk away from your screen.

EXAMINATION SCHEDULE

The planned test dates will be posted in the Canvas calendar. The professor reserves the right to move any test date. The final exam will replace the score of any exam you miss -OR- your lowest exam score if you take all exams. However, if you are satisfied with your grade before the final exam, you may skip the final exam and be guaranteed the grade you have before the final exam.
