Conducted literature searches. Created a literature review of published scholarly articles related to gentrification, displacement, studentification, and community reform. Analyzed multidisciplinary research to find associations between topics and themes like the intersection of race, gender, and university-involved expansion into surrounding communities of color to show who, when, and how the Wheatville freedom colony was displaced by fraternities at UT Austin. This project ultimately pushes for community reform through reparations and education.

Worked on multidisciplinary research to find associations between topics and themes like the intersection of race, gender, and police brutality. Conducted literature searches. For this project I engaged in participant observation of Black Lives Matters meetings in NYC, interviewed Black Lives Matters members, created a database of all Black Lives Matters protests, meetings, events, etc. and analyzed Black Lives Matters as a Movement. I created a Retrospective Report on the Black Lives Matter Movement this was a draft for the article "Neoliberal Racism and the Movement for Black Lives in the United States."
