#### GENDER AND SEXUALITY IN JAPAN

This course examines gender and sexuality in Japan during the classical (Heian), early modern (Tokugawa or Edo) and modern periods. We will consider the construction and representation of feminine and masculine gender and sexuality, both normative and otherwise. In addition to introducing important theoretical issues and intellectual frameworks that underpin the study of gender we will employ a wide variety of sources including Japanese primary sources in English translation such as novellas and films and secondary works in Japanese history, literature and anthropology. We will adopt a historical approach that considers how forms of gender and sexual expression are represented in Heian and Edo literature, how they are promoted, policed and prohibited by the modern Meiji state (1868-1912) and how cosmopolitanism in the Taisho and early Showa periods influence their construction. We will continue examining culturally and historically specific categories of gender and sexuality through the postwar and contemporary periods.

### Course Requirements

Your final grade will be determined according to the following:

Attendance and Discussion Participation: 25% - Attendance is required; if you are absent you cannot participate. Participation includes class discussion, weekly reading presentations and a presentation on your final paper. Active participation in class discussion means contributing quality comments and questions based on the reading assignment.

Weekly Reading Responses and Discussion Questions: 25% - Each Tuesday, by 11 am, you will post a 1-2 page analysis and response of the assigned readings. Do not summarize the readings but try to identify each author's objectives and argument and evaluate how the book or article fulfills these objectives. Try to relate the readings to one another or to readings from earlier class meetings. You must also submit one open-ended discussion question for each of the readings. Do not submit questions that require factual information or more data - these are not discussion questions.

Abstract and Preliminary Bibliography for Final Paper- 15% - You will prepare a one-page abstract on your plans for your research paper and a preliminary biography of at least ten library sources. No websites are allowed, but you can use articles posted online in academic journals.

<u>Final Research Paper: 35%</u> - You will complete a research project and final paper of 6-10 pages related to gender or sexuality in Japan. Additional details on this assignment will be posted on Blackboard
