Academic Learning Goals:

- Students will have an understanding of the professional roles, professional skills, and places of practice of a pediatric psychologist.
- 2. Students will have exposure to current areas of research for pediatric psychologists.
- Students will have knowledge of how to identify and treat the most common psychological and medical conditions seen by pediatric psychologists.
- 4. Students will complete a practicum experience where they are taught the professional skills of a pediatric psychologist.
- 5. Students will demonstrate a basic level of proficiency in the professional skills they are taught as part of their practicum experience.
- 6. Students will spend 10-12 hours a week completing practicum experiences including seeing patients, completing notes, completing test reports, completing case relevant readings and other preparation, attendance of individual and group supervision.
- 7. Students will complete regular clinical notes within 24 hours of having talked with a patient.
- 8. Students will be able to run a case conference.

Grading Policy

Students will complete the assigned readings and demonstrate this through participation in the course discussions. Students will complete 10 to 12 hours of practicum work each week to be determined with their immediate site supervisor. Site supervisors will evaluate each student using the TCSC practicum rating form (see the appendix of your TCSC Practicum Handbook). Practicum supervisors will be giving students a grade based on the ratings given to students on the TCSC practicum rating form. In addition, grades will be based on number of hours completed versus missed each week. Students will be graded on their case conference presentations. Grades will be determined by depth of material presented, quality of student's presentation, ability to follow the prescribed format, and the fit between the case conceptualization and treatment plan. All written materials that arise from completion of practicum work are due by May 6th.
