# **Course Description:**

This course provides an in-depth look at the intersection of women and politics and Latino politics. We will put to use the tools and theoretical frameworks from multiple disciplines to develop an understanding of Latina Politics. At the same time, we will consider the larger political landscape through both an historical and current events lens.

This course will consist of three modules. The first module will focus on the history of political participation of Latinas/os and women. Having laid this groundwork, the second module moves into an analysis of female candidates and office holders. The last module takes a broad look at the political participation of women as voters and activists.

Careful and thoughtful preparation before each class is essential. <u>All</u> readings must be completed before class. Participation in the seminar is critical to your success in the course as a result attendance is required. Grades will be based on three module exams, a portfolio, and attendance.

## **Cultural Diversity in the United States Flag**

This course carries the flag for Cultural Diversity in the United States. Cultural Diversity courses are designed to increase your familiarity with the variety and richness of the American cultural experience. You should therefore expect a substantial portion of your grade to come from assignments covering the practices, beliefs, and histories of at least one U.S. cultural group that has experienced persistent marginalization.

## **Independent Inquiry Flag**

This course carries the Independent Inquiry flag. Independent Inquiry courses are designed to engage you in the process of inquiry over the course of a semester, providing you with the opportunity for independent investigation of a question, problem, or project related to your major. You should therefore expect a substantial portion of your grade to come from the independent investigation and presentation of your own work.

# **Evaluation/ Grading Criteria:**

\*All written assignments must be double-spaced.

1. <u>Module examinations (3)</u>. There will be an exam at the end of each module that evaluates your comprehension of that module's material. You will be responsible for all of the readings, in-class films, and all of the lecture materials, including those of guest lecturers. Each exam is worth 20% of your grade, together accounting for 60% of your grade.

Module 1 Exam: October 1 – 20%
Module 2 Exam: October 29 – 20%
Module 3 Exam: December 3 – 20%

2. <u>Portfolio</u>. Over the course of the semester you will compile a portfolio that profiles a Latina office holder. You will profile the same Latina office holder for each of the four assignments. The portfolio consists of four parts that will be due throughout the semester. Before deciding on your office holder, make sure she agrees to do an interview (minimum 30 minutes) with you later in the semester as an interview makes up the last portfolio assignment. The portfolio is worth 35% of your grade.

The **first portfolio assignment** is a Political Briefing of a Latina office holder you will profile. In this 3 page memo you will briefly tell us about the candidate you chose, about the area and constituency she represents, and why you chose her. This briefing is worth 5% of your grade.

• Due September 10

The **second portfolio assignment** is a 4-5 page biography that focuses on the office holder's path to office. The biography is worth 10% of your grade.

• Due October 15

The **third portfolio assignment** is a 4-5 page analysis of the office holder's policy positions. Here you will examine what legislation she has sponsored/authored as well as what her votes have been. The policy analysis is worth 10% of your grade

• Due November 24

The **fourth portfolio assignment** is a magazine-style write-up or video of the interview you conduct with the office holder. The interview write-up or video is worth 10% of your grade

- Due during our course's scheduled final exam time, December 12 at noon.
- 3. <u>Attendance</u>. Regular class attendance and participation will make up 5% of your grade.
