Book manuscript: "Artisans of 'Inventive Genius': Atlantic Refugees, Niche Economies, and Portable Lives in the Manufacture of Polite Matter, 1640-1789." 3 chapters completed as well as sections of other chapters. I expect to finish writing this manuscript by Spring 2019.

"Mark of Disgrace or Matter of Politeness? Materiality, Repetition, and Expectation in Early Eighteenth-Century Virginia," will appear as a chapter in a peer-reviewed volume titled *Crafting Artisanal Praxis: Networks of Power in the Long Eighteenth Century*, currently under peer review at Oxford University for their Studies in the Enlightenment series, forthcoming late 1919 early 2020.

"Portable Lives: Reformed Artisans and Refined Materials in the Refugee Atlantic," to appear as a chapter in a peer-reviewed volume titled *Global Early Modern Protestantism* currently proposed for publication with Cambridge University Press. (awaiting contract) The chapter was handed in to the editor in mid-July 2018.
